TABLE HOLDER CONTRACT

Due to the current political environment and the conditions of insurance which allows these shows to take place, and in the interest of a successful event, the following rules must be strictly enforced. Please read and understand the following rules and then ADHERE TO THEM:

THERE ARE TO BE NO LOADED FIREARMS INSIDE THE SHOW. If you carry a firearm when you travel or hold a CCW permit, you must still unload your firearm before entering the show. Only security and uniformed law enforcement officials may carry a loaded firearm in the show – **NO EXCEPTIONS. If you are caught with a loaded firearm, you will be removed from the show.**

ALL FIREARMS MUST BE TIED. This is to be done in a manner that prevents the firearm from being loaded or discharged. This includes firearms that are inside display cases, boxes, and other CONTAINERS PRESUMED TO BE "SAFE". If ties are removed to inspect a firearm, they must be replaced in like fashion. Firearms with removed bolts, dismantled firearms and black powder firearms do not need to be tied. Extra ties are available at the table rental desk.

ALL LOCAL, STATE, AND FEDERAL LAWS MUST BE OBEYED. At the table rental desk copies of what the ATF considers to be the Federal laws regarding gun shows are available.

NO BLACK POWDER OR EXPLOSIVE DEVICES ALLOWED AT THE SHOW.

ANY SITUATION OR DISPLAY DEEMED TO BE OFFENSIVE, INAPPROPRIATE, OR UNSAFE WILL BE CORRECTED OR REMOVED FROM THE SHOW.

IF APPLICABLE, TAX CODES MUST BE FOLLOWED. It is the table holders' responsibility to comply.

TABLES ARE TO OCCUPIED AND DISPLAYS MUST BE OPEN FOR BUSINESS. Unless prior arrangements are made with management, **displays are to be intact from the beginning of the show until the close of the show. No carts are allowed on the floors of the show until the end of each business day and the show is closed.**

LIABILITY. *I agree to hold harmless, including any legal expenses, the producers of this show, the managers of this show, their agents, employees, contractors or owners, or the operators or owners of the facility in which the show is conducted, from any damage, loss or legal action resulting from the failure to observe the preceding, or any intentional, unintentional or negligent act resulting in injury, death or damage, whether committed by myself or any individual sharing my space or employed in my space.* INITIALS: _____
